## **Multi-Year Membership Now Available**

The American Legion announced a new pilot program in December 2023 that gives members **1** an option to pay three years' worth of dues in advance. This new option can assist members in avoiding dues increases during those three years. At the national convention in August the national organization voted to increase dues starting July 1, 2024 by \$5 per year. There is also a possible Department dues increase being voted on in July that would take effect in January 1, 2025.

The new multi-year program means members can put off the dues increases until 2027 or even 2028 for some members. But one has to act before July 1, 2024.

Members who have not renewed for 2024 can go onto legion.org/renew and pay for 2024, 2025, and 2026 at the current rate that is set to increase for most (but not all as this is based off of the local Post rate) on July 1, 2024. Members who have renewed for 2024 already can now go back to legion.org/renew and renew for 2025, 2026, and 2027.

This multi-year program is only available to individuals who go online themselves as Posts cannot renew a member for three years. National Customer Service, (800) 433-3318, may also be able to help, but the long wait times are to be expected when calling during peak hours. As an alternative we are encouraging Posts to set up computers at the Post to assist members with renewing themselves online as there are many who are not able to renew on a computer. This is a great opportunity for engagement with younger members to assist those without computer skills. The Post would still have to help the members set up an account and pay for the three-year renewal.

- Payment for the three-year membership will be upfront.
- There is not a discounted rate with the three-year membership.
- Membership cards will still be sent annually by Legion posts.
- Those who sign up for a multiyear membership will not receive a renewal notice during the time they have signed up for the multiyear membership

We are encouraging all annual members that can afford the multi-year to sign up before July 1,2024 to secure the lower rate before a dues increase. We have 420 members who have signed up to date.

If one cannot afford the three-year payment another option could be to renew online and select automatic renewal at checkout. This would stop dues renewal notices to the member and the card would be charged each year for the membership rate of the Post currently in effect.

Come over and grab a bite to eat, enjoy the music by the DJ, and share good times with everyone. The hall is large enough to accommodate everyone, and the location puts us right against the board walkway behind the center and a view of the Bay. I suspect there will be more to do for everyone. The SAL will surely have their games and items for sale nearby. We are working on more activities for the kids to share in the experience. This event is a highlight every year, and the Southern MD Region asks for donations to help support this event. There is now an online donation option for the Fish Fry at mdlegionconvention.org so please support them in the effort.

The Joint Opening Ceremony and Reception (See Schedule of times in this edition) are being sponsored by Diamond Games, and the evening is a wonderful way to kick off the Convention and everyone is invited. There is light fare and drinks provided.

A somber and moving tribute to those members that have answered the Last Roll Call is held during our Post Everlasting Ceremony on Wednesday evening at 7:00pm. This program takes a lot of work from a dedicated group of members, and if you have not ever visited this service make this the year to help fill the hall. It is a fitting tribute to our departed, and everyone should plan to attend. The remembrance of those transferred to Post Everlasting is a duty of those of us still living, and this program is the finest service one can witness.

There are so many things to see and do during our week in Ocean City, invite a fellow Veteran and family to come join us. The town has events throughout the week and they can be found on https://www.ococean.com/events/ and include Sundaes in the Park (July 14th), OC Beach Dance Party (July 15th), Movies on the Beach (July 17th), and Sunset Park Party Night (July 18th). Also this year Synepuxent Post 166's renovation and addition of the open air lounge will offer more space to share in camaraderie. The local Post always hosts events in the evenings of the convention so check out their calendar as well.

Posts again this year CAN submit ads, boosters, and sponsor golf tournament holes online. All these things can still be done the same way as previous years; however, we now have a Convention Webstore where Posts and supporters can do all the things that before could only be done by mail. All the links and downloadable forms are available on our Dept website at www.mdlegion.org. To submit ads, boosters, or golf tournament items (including registering for golf foursome, and individuals) just go to Convention Corporation website at www. mdlegionconvention.org. The ability to order a Convention Polo Shirt online is available again this year. Cutoff for the shirts is May 1, 2024. On the Convention website one can upload an ad, booster list, or do about everything that used to be mailed. Payment methods include all major credit cards and PayPal.

Again, this year Posts CAN register delegates and alternates using the webstore at www. mdlegionconvention.org. Post Adjutants will receive the Tally Sheets and registrations forms about 33 days (by about June 13th) before the Convention, and they can complete the forms and mail back the traditional way, or they can pay for the delegates online, and upload the registration forms to the item before adding to the cart.

Vendor registration can also be done on this website, and if you are aware of someone that would like to set up in our vendor area, please spread the word. Vendors will make the convention a better time for the entire Legion Family and provide needed products and services.

In closing, I pass along well wishes from myself and my family for a Happy Easter, and please do not forget to encourage all Veterans to join the Posts in commemorating Memorial Day. Take the time to invite Post 297 members and all Veterans living in your area to visit the Post or services on these special days.



Thring you greetings once again from our ■ National American Legion Commander, Daniel J. Seehafer from Wisconsin. We are looking forward to the National Commander's visit on March 16, 2024, as we sponsor the National Commander's Banquet.

On December 12, 2023, at 1Pm, a Virtual National Executive Committee Meeting was held by zoom. The primary purpose of the meeting was to discuss Resolution NO.1 (Oppose claims filing by unaccredited parties). The veterans Affairs and Rehabilitation Commission (Autrey B. James from California is the chairperson) reported on Resolution No. 1 to the NEC. The American Legion supports existing Title 38 that prohibits any party from assisting a veteran in the preparation, presentation or prosecution of a Department of Veterans Affairs (VA) Claim unless they are accredited through VA for such purpose and charging a fee to file, help or otherwise consult, in filing an initial application for VA Benefits is illegal and the American Legion has deep concerns regarding the protection and security of sensitive personal data and medical information of Military Veterans. The Flag Amendment will always be priority of concern of the American Legion until approved. As you recall, the U.S Supreme Court ruled that flag desecration is protected speech after a self-proclaimed communist was charged with desecrating the US Flag. The American Legion and all veterans were outraged that the court, in 5-4 ruling, took away the fundamental right for the people to protect their flag.

On January 31st, 2024, the Military Quality

of life Panel of the House Armed Services Committee hosted a public hearing with the Senior Enlisted Advisors to the Joint Chiefs of Staff and the services to discuss the serious issues facing service members and their



families. The hearing followed a series of round tables held last year by the panel with pentagon Officials, Military Advocates, and Military Families. During these meetings, lawmakers developed strategic legislation to address the complaints of service members and support senior leaders' efforts to improve quality of life.

The American Legion Winter Conference will be held in Washington, D.C on February 26, 27 and 28th of this year. I do plan to attend.

### CALL FOR THE 106TH ANNUAL CONVENTION THE

The One-Hundred-Sixth Annual Convention of The American Legion, Department of Maryland, Inc., is hereby called, and in conformity with the action of the One-Hundredth-Fifth Annual Convention and the Department Executive Committee, will be held in Ocean City, Maryland, Tuesday, July 16 through Friday, July 19, 2024.

#### PURPOSE

The Convention is called for the purpose of electing officers for the ensuing year, hearing and considering resolutions, and for the transaction of such other business as may be deemed necessary to come before the Convention.

#### REPRESENTATION

The Department Convention shall be comprised of representatives from each Post who shall be members in good standing of the Post by which they are elected, and all Past Department Commanders while in good standing in their respective Posts. Each Post having 15 members in good standing shall be entitled to two Delegates. Each Post having 26 members in good standing shall be entitled to three Delegates and to an additional Delegate for each additional fifty members after the first twenty-six. Each Post shall be entitled to an Alternate for each Delegate. Membership strength of the Post, for determining Delegate strength, shall be computed as of paid-up membership in Department Headquarters at the close of business on June 11, 2024. All Department and all National Officers listed in ARTICLE VI, Section 1 of the Department Constitution in the year in which they serve (excluding the Department Adjutant if serving as an employee of the Department), and all Past Department Commanders, shall be Delegates-at-large to Department Convention, with right to vote thereat, to be exercised by them with their respective Posts. Every Post shall file the name and number of the Delegates and Alternates to the Department Convention at least twenty days prior to the convening of the Convention, (no later than June 26th this **year**), and at the same time pay the registration fee of \$20.00\* for each and every Delegate, in the case of an Alternate taking the place of a Delegate such Alternate shall be required to pay the registration fee of \$20.00\* which shall be done when the substitution takes place or sooner; unless and until such registration fees of the Delegates have been paid, the Delegation is disqualified to act for any purpose, and no individual Delegate will be allowed to vote, provided, however, that the mere non-payment of registration shall not deprive a Delegate otherwise duly qualified, of the right to vote in any Region or District Caucus, on any matter (including election of officers) which thereafter is subject to ratification by the Department Convention. Post Commanders are urgently requested to have at least one member of their Delegation on the Convention floor at all times.

\*Cost of Delegates will be \$30.00 on or after June 27th.

#### **VOTING**

- Department Constitution, ARTICLE V, Section 3
  (a) On all matters of business except the election of Department Officers, members of the DEC and Delegates and Alternates to the National Convention, and except amendments to this Constitution or the By-Laws, voting shall be by voice. The decision of the chair thereon shall be final unless a vote by roll call be demanded; and upon demand of any person having proper voice, such other manner of voting shall be employed.
- (b) The election of all Department Officers, and National Officers, shall be by roll call except where, in the case of individual offices, the necessity of a roll call is dispensed with by unanimous consent.
- (c) The election of members of the DEC, and Delegates and Alternates to the National Convention, shall be in accordance with such rule as adopted by the Caucus in and for the Region from which such members, delegates and alternates are elected, but in no case, shall any such rule prevent the nomination of any member from the floor of such Caucus by any person having proper voice thereat. Voting at Caucuses shall conform to the provisions of Subsection (d) hereof.
- (d) In all voting, the vote of each Post shall be equal to the total number of delegates to which such post may be entitled. Each delegate shall be entitled to one vote. The vote of any delegate who may be absent shall be cast by the delegate's alternate, and the vote of any delegate absent and not represented by an alternate shall be cast by the majority of the present delegates from the member's post. An alternate whose delegate is present may nevertheless move into the place of an absent alternate whose delegate also is absent, and thereby acquire the right to vote, provided said alternate delegate is the senior alternate present at the time. Alternates shall have all the privileges of delegates but may only vote as herein set forth; provided the alternate's registration fee is paid. At the conclusion of all roll call voting, for each individual election required to be conducted by the Department Convention, the Department Officer conducting such elections shall ask if any Post desires to amend or change its vote;

- or ask does any Post, which has not cast its vote during the roll call vote, now wish to cast its vote. No Post shall be allowed to pass more than one time. After the Department Officer conducting the election has made the aforesaid announcement and taken due note of any changes in voting and has recorded the vote of any Post which originally passed, then the conducting officer shall announce that the voting is closed and direct that the tally be taken, and the results announced.
- (e) All Past Department Commanders, while in good standing in their respective Post, shall be delegates for life to all Department Conventions with voice and vote, to be exercised by them with their respective Post and all Region or District Caucuses at which any election provided for in this Constitution shall be held, and at which their respective Post may be entitled to vote. The failure of such Post to properly register its delegation shall not deprive such Past Department Commander of their right to vote, provided the Past Department Commander is properly registered as a delegate.
- (f) All Department Officers as set forth in Article VI of this Constitution, with the exception of Department Officers concurrently serving as a paid employee of the Department, and National Officers of this Department shall be Delegates-at-large to Department Conventions, with the right to vote thereat, in the year in which they serve, to be exercised by them with their respective Post; provided, however, that nothing contained herein shall give any person the right to more than one vote.

#### **ELECTION**

The following Officers are to be elected. A majority of the authorized vote of the Convention shall elect: (Per ARTICLE V, Department Convention Section 4)

Section 4 (a) The Department Convention shall elect a Department Commander, a Department Senior Vice-Commander, a Department Judge Advocate, and a Department Treasurer, a National Executive Committee member and an Alternate National Executive Committee member for the respective terms for each office as specified in Section 4b hereof. The Department Convention shall elect such other offices as may be authorized by the Department Convention for such terms appointed by the Department Convention.

**Section 4 (b)** The Officers positions listed in Section 4 (a), elected by the Department Convention shall be nominated and elected for office in the following sequence and for the term of office, as listed:

Department Treasurer – 1 Year.

Department Judge Advocate - 1 Year. Department Senior Vice-Commander – 1 Year. Department Commander – 1 Year

### REGION CAUCUSES (ARTICLE V, Sections 6-7-8-9)

A caucus shall be held by each Region during, or not more than twenty days prior to, the convening of each Department Convention, at which caucus the election of the Region Commander, (serves concurrently as Department Vice-Commander for said Region), Region Vice-Commander, District Commanders, District Vice-Commanders such Department Executive Committee members, and Delegates and Alternates to the National Convention of The American Legion to which such Region may be entitled by this Constitution shall be held. It shall be the responsibility of the Region Commander in and for each Region to see that at least fifteen days prior notice of any Region Caucus convened for the above purposes shall be given by mail to the Commander of each Post in the Region, and no such Caucus shall be deemed legally convened in the absence of such notice; provided, however, that any Region may caucus at any Department Convention upon three hours notice by announcement from the Rostrum, and all the purposes of this section may thereafter be fulfilled just as though prior written notice had been given. The action of such Region Caucus as to the election of any of the officials named in this section shall not be final until ratified by the Department Convention.

**Section 7.** A quorum shall exist at a Department Convention or at a Region Caucus when one third of the Posts in the Department or Region, as the case may be, are represented by duly elected Delegates or Alternates.

Section 8. Delegates to National Convention. Each Region in Caucus not more than twenty days prior to the convening of the Department Convention shall elect one delegate and one alternate delegate to the National Convention, this delegate and alternate delegate is to represent the first thousand members of their respective Region; there shall also be elected a delegate and alternate delegate for each succeeding thousand members.

The five Department Delegates shall consist of the Department Commander, the Department Commander for the immediate prior year, the Department Adjutant, the Alternate National Executive Committeeman and the Department Senior Vice-Commander who hold office at the convening of the next succeeding National Convention. The alternates for these delegates shall be appointed by the Department Commander.

Any additional delegates and alternate delegates are to be elected by the Region with

the highest percentage of their previous year's membership as of the day that determines the Department Convention membership strength for the Region.

**Section 9.** Region Election of DEC Members. Each Region in Caucus not more than twenty days prior to the convening of the Department Convention shall elect one representative to the Department Executive Committee for each unit of 500 members or major fraction thereof in the said Region.

The membership strength of said Region for this purpose shall be computed as paid up membership in the Department Headquarters at the close of business on the 35th day prior to the convening of the Department Convention or as of July 1st, in each year, which ever date shall first occur.

In the event any Region shall have less than its first and only unit of 500 members, it shall nevertheless be entitled to elect one representative to the Department Executive Committee.

The distribution of the Regions' representatives to the DEC shall be divided in an equitable manner between the Districts of the Region utilizing the membership strength of each District.

The Region shall submit the names of all elected as above for ratification to the Department Convention such ratification constituting election. At such Caucus each Post shall be entitled to the same number of votes as for the Department Convention. No Region Caucus for the purpose of such election shall be convened sooner than **June 26**th, **2024**.

#### **MEETINGS**

The opening Joint Session will begin at 8:00 PM, Tuesday July 16, 2024. All business sessions of The American Legion, Department of Maryland, will be held in the Convention Hall (Location to be determined) and will start promptly at 8:00 AM on Wednesday, July 17th, Thursday, July 18th and Friday, July 19th, unless changed by the Convention or Department Executive Committee. A quorum shall exist at the Department Convention when one-third of the Posts in the Department are represented by a duly elected Delegate or Alternate.

#### CREDENTIALS CERTIFICATES

For Credentials Certificates for Delegates and Alternates. A check made out to The American Legion, Department of Maryland, at \$20.00\* per Delegate, and MUST accompany the Credentials Certificate. All Constitutional Delegates (ART. VI) and Past Department Commanders must also pay the \$20.00\* Delegate Fee or they can not vote. It is extremely important that the certificates be

forwarded to Department Headquarters as soon as possible after June 11, 2024 (35<sup>th</sup> Day before the Department Convention). District Commanders should personally check each Post under their supervision to see that the above is complied with. All Post Adjutants are charged with the responsibility of returning the Credentials Certificates to us at the earliest possible moment. *The delegate fee shall be* \*\$30.00 per delegate on or after June 27th.

#### **AMENDMENTS**

Amendments to the Department Constitution and By Laws must be submitted in typewritten form to Department Headquarters by **June 7th**, **2024** in time for the Department Adjutant to forward copies to each Post in the Department at least 30 days prior to the convening of the Convention. These amendments require a two-thirds majority of votes of the representation casting votes on the amendment at the Convention. However, the Constitution may be amended without notice by unanimous vote at any Department Convention. (ARTICLE XV, Section 1).

#### RESOLUTIONS

Resolutions shall be submitted typewritten, in triplicate, to the Resolutions Committee at the Convention, or prior to June 7th to Department Headquarters. By order of the Department Executive Committee, each resolution MUST have supporting documents and authority attached to each copy. Resolutions submitted to Department Headquarters prior to June 7th will receive preferred attention. Those submitted after that date will be considered only if the Convention Resolution Committee considers them to be of paramount importance to the Legion.

#### SPECIAL NOTICE

The thirty-fourth Annual Department Convention, 1952, unanimously resolved no one should be allowed on the main portion of the Convention floor on election day except Officers, Delegates, Alternates and working press. (Ref: Resolution #13)

#### POST OFFICERS

ARTICLE VIII, Sec. 6 of the Department Constitution states, "All Post Officers for the ensuing year shall be elected, or appointed as prescribed in the Post Constitution and Post Standing Rules, at least twenty days prior to the opening of the Department Convention and they shall assume their duties as such within twenty days after the closing date of the Department Convention." YOU MAY HOLD YOUR INSTALLATION PARTY ANY TIME YOU WISH; YOUR POST OFFICERS MUST TAKE OFFICE DURING THE TIME ABOVE STATED. THE DEPARTMENT EXECUTIVE COMMITTEE HAS REQUESTED

THAT EACH POST FILE A COPY OF MEMBERSHIPELIGIBILITY DOCUMENTS FOR EACH POST COMMANDER AND ADJUTANT WITH DEPARTMENT HEADQUARTERS. THE DOCUMENTS WILL NOT BE RETURNED BUT RETAINED IN DEPARTMENT FILES.

NOTE: DEPARTMENT OFFICERS, COMMISSION, COMMITTEE CHAIRMEN AND DISTRICT COMMANDERS MUST HAVE THEIR WRITTEN REPORTS IN DEPARTMENT HEADQUARTERS ON OR BEFORE JUNE 1ST OR THEY WILL NOT BE DUPLICATED FOR THE CONVENTION

#### REPORTS

- 1. You are urged to promptly file your Certificate of Elections of Post Officers which MUST be signed by both the Post Commander and Adjutant. The Certificate on the bottom of this form means exactly what it says. You MUST EXAMINE the service record of each of your Post Officers to certify their eligibility.
- 2. Consolidated Post Report Form should be filed promptly, but NLT June 1, 2024.
- 3. All other Report Forms. If you have lost or misplaced any of these report forms, send an e-mail or call Department Headquarters and ask for a duplicate.

#### REGISTRATION

For Tuesday the Registration Desk will be open at the Convention Hall beginning at 7:30 AM, July 16th. DO NOT SHOW UP BEFORE THEN AND EXPECT US TO ACCOMMODATE YOU. IT IS IMPOSSIBLE FOR US TO OPEN EARLIER THAN 7:30AM ON TUESDAY.

NO CREDENTIALS ARE REQUIRED FOR ATTENDANCE AT DEPARTMENT LEGION COLLEGE. EVERYONE WILL BE GRANTED ACCESS TO THESE COURSES WITHOUT CREDENTIALS.

On Wednesday, Thursday and Friday the registration office will open at 7:30 AM. You are urged to pick up your Delegate's Credentials and badges as soon as possible in order to facilitate the business of the Convention. A POST COMMANDER OR ADJUTANT MAY PICK UP THEIR POST DELEGATION REGISTRATION PACKET. ANY OTHER DELEGATE PICKING UP THE POST DELEGATION PACKET MUST PRESENT A WRITTEN AUTHORIZATION FROM THE POST COMMANDER OR ADJUTANT LISTING THEM AS THE AUTHORIZED DELEGATE TO SIGN FOR THE PACKET. ARTICLE IX, Section 2 of the Department Constitution provides that the amount of annual Department dues shall be determined by the Department Convention. Consequently, we hereby notify you that dues will be set and voted upon as usual by the Department Convention.

PLEASE DO THIS AS SOON AS YOU ARRIVE IN OCEAN CITY, BUT NOT BEFORE 7:30 AM ON TUESDAY, JULY 16TH. A POST COMMANDER OR ADJUTANT MAY PICK UP THEIR POST DELEGATION REGISTRATION PACKET. ANY OTHER DELEGATE PICKING UP THE POST DELEGATION PACKET MUST PRESENT A WRITTEN AUTHORIZATION FROM THE POST COMMANDER OR ADJUTANT LISTING THEM AS THE AUTHORIZED DELEGATE TO SIGN FOR THE PACKET. ALL DELEGATES MUST BE PAID.

THERE WILL BE A MEETING OF THE 2024-2025 DEPARTMENT EXECUTIVE COMMITTEE. THIS IS TO BE HELD IMMEDIATELY FOLLOWING THE CLOSE OF THE DEPARTMENT CONVENTION.

THERE WILL BE NO FEE FOR LEGION COLLEGE THIS YEAR. PLANNING IS UNDERWAY TO OFFER COURSES, THE EXACT FORMAT IS STILL UNDER DISCUSSION. (But note there will be no pins or Certificates given out this year.) ## The American Legion, Department of Maryland Black History Month - Honoring our African American Veterans, Historically Black Posts, and Department Leaders

This is our fifth anniversary of publishing an article highlighting the achievements of Black Veterans and Historically Black Posts in Maryland. Again, this year an exploration of the history of service within these communities and the deep pride that exists is illustrative of the patriotism that exists in the hearts of all Americans.

This year the Department continues to pay honor and tribute to these deserving Veterans and hopes that the information shared highlights and educates our members about the deep history and record of service of the Posts and Veterans in/from Maryland, the Black communities, and at the Department level within The American Legion. The space available for this article is limited and all efforts are being made to include as much detail as possible, the extensive histories are far deeper than we could cover in a few pages. All are encouraged to continue to investigate and expand their knowledge of the stories. This year the article will explore the history of the founding of Randolph Furey Post 170 in Pomonkey, then we will highlight the life and career of Medal of Honor recipient Augustus Walley, and finally updates on Waverly Woodson and on the "Six Triple Eight" from previous years.

In previous year's editions we highlighted the founding and history of Post 14, Post 19, Post 55, and Post 77. This year we will look at the founding and history of Randolph Furey Post 170 in Pomonkey. Recounting the history of Post 170 leads back to the end of World War II and underscores their success at providing leaders to the Department over the last half century.

In Southern Maryland's history after the Civil War many communities of freedmen developed among the freed slaves and free blacks in the area. The segregation of the Jim Crow era persisted into mid-20th century and strong community

associations served these communities. African American Churches and separate fraternal orders like the Prince Hall Masonic Lodges served the communities where other organizations did not permit membership to minorities. Although The American Legion had no formal segregation by race in its organization, the practices of segregation during this period saw the formation of Posts predominantly segregated throughout the Department through much of the first 50 years of the organization. In the Charles County community of Pomonkey (named for the Pamunkey tribe of Native Americans from the area) a group of fifteen veterans organized a small Post in 1946. Post 170 was commanded from 1951 to 1955 by a retired U.S. Navy Chief named Randolph Furey. Commander Furey passed away in 1960 and the Post was renamed in his honor in 1961. The Post served the community and met at the Elk's Lodge until they moved to the current location on Livingston Road in Indian Head. They first rented the facility that consisted of a building and fourteen acres of land. In 1976 the Post was able to purchase the property that now boasts the Post home, baseball field, and outdoor venue. The Post is active in programs supporting the four pillars and has demonstrated an ability to develop leaders that have risen to serve the Department over many years, including leadership after our recent reorganization.

The Post has been the home Post to several Southern Maryland District Commanders, two Department Vice Commanders, and a Department Commander, who went on the serve as a National Vice Commander. Robert Johnson,

our Department's first African American Department Commander in 1995, was a distinguished member of the Post and Department. Bob also served as the first African American elected as a National Vice Commander of The American Legion in Charlotte, NC at the 84th National Convention held in August 2002. While the Post had numerous District Commanders over their history in Southern MD, after the reorganization in 2021 the Post has been the home to both leaders who have served as the Department Vice Commander from the Southern MD Region. John R. Countryman Jr. served from 2021-2023 as the Department Vice Commander from Southern MD and Billy Hill is the incumbent Department Vice Commander elected in July 2023. There are several other leaders from the Post leading commissions and committees in the Department. These current officers and chairpersons carry on the traditions of leadership for our Department reflected by Post 170 leaders over the years. Communities around Maryland have leaders working hard and many go unnoticed for their dedication.

Another unnoticed and mostly hidden story involves a soldier from Maryland who received our nation's highest award for bravery in combat yet largely goes unknown. Augustus Walley was born in Reisterstown, MD in 1856. At the time of his birth Augustus was an enslaved person, yet just 25 years later he would show courage in battle against hostile Apaches that would lead to the awarding of the Medal of Honor in 1890, 9 years after his actions. He was freed at age 9 and worked as a laborer

for over a decade before joining the 9th U.S. Cavalry in November 1878. The 9th U.S. Cavalry was one of the Army's segregated Regiments nicknamed "Buffalo Soldiers" during their campaigns against the Native American tribes during the Indian Wars. The Buffalo Soldier units were established by Congress in 1866 as the first peacetime all-black Regiments in the Army. Private Walley's actions leading to the award of the Medal of Honor were described in a Baltimore Sun article from February 12, 2018 by Chris Kaltenbach:

"Walley earned his Medal of Honor during an August 1881 engagement with Apaches in the Cuchillo Negro Mountains (known today as the Sierra Cuchillo), in what is now southwestern New Mexico. Sent after a band of Apaches had attacked a nearby ranch, Walley was among a troop called upon to provide cover for a group of trapped soldiers. Although many were able to escape, one was too badly injured and remained behind.

"Walley grasped the situation," reads a plaque hanging inside the armory, "and in the greatest tradition of the cavalry mounted his horse and galloped to the fallen soldier, rescuing him and withdrawing under enemy fire to the rest of his unit."


Discharged from the 9th Cavalry in November 1883, he re-enlisted the next day in the 10th Cavalry, another Buffalo Soldier regiment. While fighting in Cuba during the 1898 Spanish-American War, he helped rescue a squadron commander, Maj. James Bell, under similar circumstances. Nominated for a second Medal of Honor, he was awarded instead a "certificate for gallantry in the preservation of human life" from his regimental commander."

Walley served in both the Spanish American War and Philippine-American War before retiring from the Army in 1907. Later, in 1918 he volunteered for service at Camp Beauregard in Louisiana but was turned away because of his advanced age at 61. He did, however, stay and work at the camp for the remainder of WWI. He returned to Baltimore, settling on Etting St., after the war rising to the rank of First Sergeant and serving for over 31 years in uniform. His family recounted that he rarely talked about his service or his actions in the wars. Augustus passed away in 1938 and is buried in Saint Luke's Cemetery in Reisterstown. The Indian Wars and their history are not as studied as other period of conflicts, and this leads to the loss to time of the memories of these great warriors. Augustus Walley's service and deeds rank among the highest of anyone who has served our great nation. Rising from his birth in slavery, to battling with segregation and the ill will many African American pioneers faced, he forged a legacy of bravery and patriotism that serves as a model for all to follow in life. While First Sergeant Walley was awarded our nation's highest honor for a soldier, ensuring recognition of heroic actions among African Americans serving during our nations earlier war periods has gained momentum over the

last decades, however it remains an unfinished task

In previous articles several service

members and units have been highlighted. These articles also championed the push to give proper recognition. There have been some updates on the efforts and successes on this front.

Jr. on Omaha Beach during D-Day when assigned as a medic for the segregated 320th Barrage Balloon Battalion. The 320th was the only African American unit to land on Omaha Beach on June, 1944. While several elected leaders, including Senator Chris Van Hollen, are seeking the Medal of Honor for Cpl. Woodson's bravery and actions that day. Cpl. Woodson was wounded and continued to treat as many as 200 wounded comrades over a thirty-hour period before he collapsed himself. Woodson, promoted to Staff Sergeant during his service during Korean War era, passed away in Gaithersburg in 2005 was interred at Arlington National Cemetery. In October of 2023 a ceremony was held to present his widow Joann with the Bronze Star and Combat Medical Badge earned by her husband decades ago on the beaches of Normandy.

Finally, an update on the 6888th Central Postal Directory Battalion who were awarded the Congressional Gold Medal in 2022. The Department of Maryland and The American Legion passed resolutions commending their service and urging Congress to award the unit the Gold Medal for their service during WWII. Two members of the Department, Edna Cummings and Elizabeth Helm-Frazier have continued to work tirelessly for the recognition of these exceptional women. In 2023 the Department of Defense honored the Battalion Commander of the 6888th Lt. Col. Charity Adams Early by renaming Fort Lee in Petersburg, Va to Fort Gregg-Adams. Lt. Gen. Arthur J. Gregg was the first African American to be promoted to the rank of Lt. Gen. in 1977. Lt. Col Adams led the 6888th throughout the service in the European Theater and was the highest ranking African American women in the Army by the end of WWII. In April 2024 an exhibit featuring the 6888th will open at the United States Army Women's Museum on Ft. Gregg-Adams. This museum showcases female

veterans of United States and is a wonderful museum to tour of in the Petersburg area. The continuing efforts for recognition previously denied is a valiant and needed endeavor. Those individuals, families, and organizations maintaining the drive for these efforts are to be commended and encouraged.

Over the last five years the process to highlight a few personal stories and deeds of Veterans has started many conversations. The continuation of these conversations and the development of a better understanding of the impacts these men and women had on the world around them is still far from complete. There are many more personal stories, and Post histories, one could highlight in these articles. It is tough to not only fit the stories in the brief space available but then to pick which stories to highlight. There are so many stories to tell, and next year we will surely recount more of these deeds. My hope is to spark the efforts to save these memories for posterity and promote a celebration of a part of our history that is not as familiar as many other aspects. The elevation of these stories and history shows the proud traditions, and clearly answers the question of why the members would want to maintain their heritage.

The recounting of the actions and works of the heroes from this article can serve as a reminder that many served and were never appropriately recognized. Striving to educate and illuminate the deeds of a few is a calling for all to preserve the memories and incidents of our associations in all wars.

It is past time to make this a constant effort to promote all Veterans' contributions, and share the history, good and bad, to highlight the proud history of the African American Veterans and the accomplishments shared with the Department of Maryland. The way ahead is lit brightly by their deeds and the inclusion of all Veterans is the solid foundation for the future!



There is a level of accountability we should expect from our Post Officers and paid members. If nothing else, come to the meetings!

Southern Maryland Region has recognized the need to change the culture, expectations, focus, and leadership style. We developed a plan, stuck to it, and followed the promise. When it comes to accountability, never be afraid to dismiss members from the team if you believe they're "standing on your air hose" or "holding everyone back. We are moving forward; our history supports it, and members expect it. Help a Veteran accomplish a goal this week. Your engagement matters, then follow us to the convention; we won't be hard to find, we will be the Region leading from the front, so you can read who we are on our backs!

At this point we needed the Post to do their part, and they have done it! Our Posts have taken off this year by executing their pillar programs, hosting events within the community, improving relationships between Posts, and promoting healthy lifestyles. I have never been this excited about the future as I am right now. Today, I thank you for your support or active involvement in the work of the American Legion. This version of District Five is only the beginning of a District that serves Veterans, serves the community, and continues to look for solutions to complex problems across the Department. 
#### From the Desk of District Six

# The Fight for the Post Quorum

There have been times when the Post Commander has shared three strokes of the gavel, and we began to look around the room, wondering if we had enough for a quorum. Do we have members coming from other rooms or perhaps the parking lot? Just so we can make sure we have a quorum. We all know something is happening, but rarely do we address this critical point because we hope things will get better. A quorum is a pre-established number of members required to transact business for the good of the Post, Committee, or Unit.

The American Legion is only as strong as our Posts and our membership. The fact that Posts are challenged by inactivity and, in some cases, lack of leadership is not all that new but very important to the future of our organization. There are various reasons for this shortfall, and all of them can be overcome. To have an active and engaged Post, someone in the room must "care" about the American Legion, be there for the "greater good," and be connected to the mission. When you're doing something you don't care about, it becomes stress. This can be one person, but one person will never be a quorum, only an individual. Other elements are also there when there is a

need for a quorum. These elements include lack of interest, lack of time, lack of resources, or a bad experience with the Post members.

We are at the point where even the elected officers require nudging, training, and to be held accountable for the position they took an oath to execute. The Quorum should be where we can see the finish line but disagree on the road to getting there. I was once told, "Disagreement is not bad; you don't want to surround yourself with people who always agree with you." However, if no one is there, how can we make decisions?

Today, we have Posts with over 600 members. However, there is a struggle to reach the eight-member Quorum. Why, you ask? We are experiencing internal and external change. Internally, we have lost some of the Comrades from eras such as WWII, Korea, and Vietnam. The culture of our organization is vastly different. Today, members are there for different reasons. Externally, the world situation in areas such

as the economy, technology, and even our values have become more about the members and less about the Veterans beside them. The veterans beside them used to be why many looked after each other, but today, the social benefits have suffered, and members don't talk to each other like old buddies.

How do we win the fight for a Quorum? Get personal! Call every member and get their contact information. Have an honest conversation with Comrades and create a bond with them. Don't be alarmed when they say, "I never hear from anyone," because some are only contacted when their dues are late. Generate a list of activities within the Post and continue to show appreciation for their service and support for their family. They want to know that we care about them as members! Develop a more robust level of Post Pride, then consider connecting with other posts in your area. The answer lies in your consistency. In short, we are talking about a culture change, which takes time.

As I stated earlier, someone has to care. Some of your members will say, "I don't have time" or "I don't know how to do it." Don't let them off the hook. These are excuses that must be ushered out the door. As leaders, we can't stop and retreat at the first hint of pushback. They usually want to know they're essential to the Post; however, if you don't ask, it doesn't matter. If we want our organization to last, we must understand where we are and decide where we want to go. Thousands of new Veterans are born every day, and we want them in our organization. We want them on our roster and in our Quorum. I challenge all Posts to build a Quorum based on the principles of the American Legion and the values of your Post. You will undoubtedly win the war for a Quorum if you consistently achieve the small wins. Build a Quorum with members that care, share your vision, then march to your goal with all things considered.

and privileges of American citizenship. In 2007, the contest's official name became the American Legion High School Oratorical Scholarship Program – A Constitutional Speech Contest. This contest provides a unique focus on Constitutional study and American history.

#### **Contest Description**

Contests are usually held January through March. The national competition is held in Indianapolis in April. High school students under age 20 are eligible. Each contest has two phases for each contestant:

- Eight to ten minute prepared oration
- Three to five minute assigned topic presentation
- Competition begins at the post level and advances to a department competition
- Department winners compete against each other in two speaking rounds
- Legion department representatives certify one winner per department to the national contest
- The national contest concludes with a final round, that decides the top three finishers Scholarships

The largest scholarships are offered at the national competitive level. To date the American Legion Oratorical Scholarship Program has awarded more than \$3million dollars in scholarships to students at the national level of competition. It currently awards \$203,500 annually to department winners competing at the national level. Each department winner who is certified into and participates in the national contest's first round receives a \$2,000 scholarship. Those who advance past the first round receive an additional \$2,000 scholarship. The overall national contest winner gets a \$25,000 scholarship. Second place takes home \$22,500, and third place receives \$20,000.

As our youth are our future, we must commit to serving the nation's children and caring for the children of our comrades and active-duty military. The American Legion High School Oratorical Scholarship Program provides a great opportunity for students to prepare for future success in their chosen vocation or profession. Being able to address an audience, communicate effectively, articulate a point of view, and speak with intention, are the essential characteristics of the oratorical program. The lack of interest in hosting a contest and recruitment of students in District 6 to be a part of this program, highlights the need for improved post level support and Legionnaire participation. See you at the convention, we will be out in front, so you can read more about who we are on our backs!

### VETERANS BENEFITS ADMINISTRATION

For Veterans looking for clarification on the wide range of VA benefits available to them, the **2023 VA Federal Benefits Booklet** serves as a guide to help them make the most of their post-service lives. It includes information on everything from health care and educational assistance to housing aid and career development initiatives. Safeguarding your identity: Keeping your VA benefits safe from identity theft and fraud. In the contemporary digital era, identity theft is a more likely occurrence than home burglary or car theft. As a Veteran, you hold more sensitive information than an average citizen, necessitating careful protection of your personal accounts, Veteran ID, VA.gov account login, and any benefits you may receive, such as disability compensation and education benefits. Veterans are highly susceptible to fraudulent activities, online scams and deceitful individuals. Identity theft occurs when hackers obtain sensitive Personally Identifiable Information (PII) like credit card details to sell on the dark web or use for their own gain. Identity theft is a difficult crime to prevent, but there are several measures you can take to safeguard yourself and your VA benefits. It's essential to stay vigilant and familiarize yourself with the following frequently occurring common online scams:

**Direct Deposit/Payment redirection:** A bad actor obtains PII to unlawfully access and gain control of Veterans' and beneficiaries' accounts.

**Phishing:** A fraudulent practice where an imposter creates a fake online persona to deceive Veterans and their beneficiaries into providing PII.

**Email:** A type of scam in which a fraudster sends a fake email, often promoting a contest or reward, to trick a user into clicking on a malware link or obtain sensitive personal information.

**Phone:** A scammer may pose as someone you trust and try to obtain your money or personal information to commit identity

theft

**Spoofing:** A caller disguises the information shown on caller ID, giving them the ability to impersonate a specific person from a certain location.



**Wired:** A type of fraud that involves the use of some form of telecommunications or the internet.

**Forgery:** The act of forging or producing a copy of a document, signature, banknote or work of art.

**Malware:** One of the top cyber schemes used by bad actors to infect computers. They may even hold your computer "hostage" with malware until you agree to pay a ransom; this type of malware is also known as "ransomware."

Here are some identity theft prevention tips Veterans can follow to protect themselves:

- Screen emails carefully, and only open emails from senders you know and trust.
   Delete and block emails from unknown or suspicious senders.
- Be cautious of popups and links on websites, emails and texts that can be used to infect your device with harmful malware.
- Limit PII when you post online, such as your address, date of birth, workplace, or kinship details.
- Delete old social media accounts and limit online presence and available biographical information.
- Maximize privacy settings on all active social media accounts to protect information from unknown users.
- Do not accept friend or connection requests from individuals with only an online presence. Only add friends or connections you know and trust in real life, not those who you have only met online.
- Download strong antivirus software to protect yourself from malware attacks.
- Be aware of signs of a malware infection.
   If your computer runs unusually slowly or frequently crashes without explanation, it may be an indication it is infected with malware.
- Never send bank information or payment to "online friends" or others. Scammers may threaten to destroy your files or data if you do not send payment or banking information. Be alert! Identity theft is not

always committed by strangers.

- Frequently change and maintain strong passwords and never use PII in the password.
- Be cautious of telephone numbers on your caller ID. Scammers can change the telephone number (spoofing) to make a call appear to come from a different person or place.
- Only shop on sites that are validated—go directly where you want to shop. Check the URL for spelling mistakes or errors.
- Use a credit card instead of a debit card.
   Credit cards typically provide added protection against fraudulent charges.
- Do not sign forms that are not VA generated or are a third-party authorization for someone to provide "behind-the-scenes" claims assistance.

If a Veteran believes their identity has been stolen, they should contact the Federal Trade Commission (FTC). Identity theft can be reported to the FTC at IdentityTheft@va.gov. If a Veteran has concerns about their VA services being impacted by identity theft, they can call the toll-free VA Identity Theft Helpline at 1-855-578-5492.

### Veterans Benefits Banking Program (VBBP) & VETCENTS

The Veterans Benefits Banking Program provides Veterans with a safe, reliable and inexpensive way to receive and manage their VA monetary benefits. VBBP participant banks and credit unions will provide nominimum-balance, low-to-no-cost checking accounts to direct deposit customers. VBBP helps Veterans and other VA beneficiaries choose among the three available options for receiving VA monetary benefits:

- Direct Deposit into an existing or new bank account
- Electronic funds transfer to a Direct Express® prepaid or other prepaid card
- Mailing of paper checks to pre-approved beneficiaries

**VetCents** was created by the Military Family Advisory Network (MFAN), a national nonprofit, to connect families to information and resources that they need to reach their financial goals. Today, VetCents is fully integrated in VBBP, multiplying VetCents' potential to support the financial wellbeing of those who have served our

country as they navigate their financial journey. VetCents is provided at no cost to Veterans, Veteran beneficiaries and Veteran caregivers thanks to support provided by the Wells Fargo Foundation and the ABA Foundation. #### **Veterans Affairs Life Insurance (VALife)**

VALife is VA's first new insurance program in nearly 50 years, and since Jan. 1, 2023, has provided Veterans with the peace of mind that comes from knowing loved ones will have some funds after their departure. VALife eliminates time limits to apply, increasing access to more Veterans than ever before. The program offers guaranteed acceptance, whole life insurance to Veterans aged 80 or under with any level of service-connected disability (0-100%). Veterans aged 81 or over may qualify if they meet certain criteria and apply within a certain timeframe.

VA is the nation's 12th largest life insurer and has issued \$950 million in coverage to 31,400 Veterans for VALife in its first year alone.

#### **Key features of VALife include:**

- Coverage up to \$40,000, available in \$10,000 increments
- No health questions or medical exam to enroll
- No deadline to apply if you are age 80 or under
- Convenient online application and enrollment, and
- Cash value that builds over the life of the policy, after the first two years of enrollment

VALife premium rates **are not** based on medical underwriting and **will not** increase over the life of the policy. Premiums are based on the Veteran's age upon enrollment and the coverage amount selected. VALife premium rates are competitive with, or better than, similar private sector guaranteed acceptance programs. VALife does not offer waiver of premiums.

### VETERANS HEALTH ADMINISTRATION Mobile Medication Units

Mobile Medication Units provide care to Veterans with Opioid Use Disorder (OUD) who otherwise may not be able to engage in services at brick-and-mortar opioid treatment programs. Consistent with the

Office of National Drug Control Policy's charge to expand access to medications for OUD via mobile medication units, the Veterans Health Administration (VHA) is supporting a pilot expansion of mobile medication units across VA. The Perry Point VAMC was awarded a \$1.2 million grant in Fiscal Year (FY) 24 to hire staff, customize a vehicle, and support supply costs in preparation of launching mobile medication services to our Nation's Veterans. During FY25, after completion of the pilot, the mobile medication unit will be deployed into the community to bring these critical services to Veterans.

The proposed plan is to deploy into Cecil and Harford counties initially. Future plans to deploy into the counties on the Eastern Shore of Maryland will proceed after successful deployment into counties close to Perry Point. Veterans who currently cannot receive care for OUD will now receive life-saving care in their local community. Reduction in substance use relapse is expected with the deployment of a mobile medication unit. Veterans who currently live in the community and who use mobile medication unit care will likely engage in fewer visits to local emergency rooms and

inpatient facilities. Reduction in the number of unexpected opiate overdoses is expected when mobile medication units are deployed, thereby reducing the overall burden on local emergency responders. Provision of mobile medication units reduces the need for Veterans to secure care in the community, opening more resources for non-Veterans in need of OUD care.
